# 1.0 Introduction

Infants and children at times require transfer to a hospital outside of the Republic of Ireland for further care and treatment. This may require medical assistance from nursing, nursing and medical or critical care teams.

# 2.0 Definition of Standard Operating Procedure

The term '**Standard Operating Procedure**' is a way of carrying out a particular course of action and includes operations, investigations, pharmaceutical treatment, examinations and any other treatment carried out

# 4.0 Objectives of Standard Operating Procedure

To ensure the safe and timely transfer of infants / children to another hospital outside of the Republic of Ireland

NEOC – National Emergency Operations Centre

#### 6.0 Procedures

#### **Nursing Administration**

- Communication received from the transplant centre to say potential donor offer.
- Identify latest time patient can arrive at receiving hospital
- Request priority one transport from NEOC and discuss timeline.
- Notify medical team and discuss re need for medical / nursing team to escort
- Recheck and confirm passport details with NEOC.
- Confirm equipment needs of child e.g. weight, luggage e.g. car seat
- Contact parents and ensure mobilizing in progress. Contact Gardaí if required to assist.
- Keep in regular contact with parents
- Confirm transport arrangements and equipment requirements with NEOC
- Provide financial assistance to staff for mission if required
- Confirm transport details with transplant coordinator in receiving hospital.
- Provide ongoing support to family
- Confirm return journey for staff organized if required
- Please see ward transplant SOP if nursing escort required.
- Update relevant teams if transfer occurs out of hours


